I have received your LEAD Scholars Academy admission and understand the following obligations:

LEAD Scholars Academy Requirements:

- I will enroll in the following elective classes: LDR 2001, 2002, 3215 and 3950 (required LEAD Scholars Academy classes) during fall/spring of my first and second year. However, I may drop or withdraw at any time (please note that dropping/withdrawing your LDR class will not allow you to receive the benefits and fellowship listed below).
- I will notify the LEAD Scholars Office of any changes regarding my status as a student at the University of Central Florida and/or in the LEAD Scholars Academy (LSA).
- I will maintain an overall **3.0 overall cumulative GPA** and will complete 24 credit hours each academic year.
- I will register for and satisfactorily complete all LEAD Scholars Academy courses **with a B average** or better in my LEAD Scholars courses during the two-year program.
- I will participate in the defined number of co-curricular leadership events, as defined by the program, each semester.
- I will complete the hours of community service specified in my LEAD class each semester while in the program.
- I will attend LEAD All Access **5:30pm-9pm on the first Friday of the fall 2021 semester (August 27th, 2021)** and attend a *Leadership Week* workshop in spring 2022.
- I will remain in good standing with the LEAD Scholars Academy by fulfilling the above program obligations.
- I understand that I must be in good standing with the University and comply with all responsibilities of the Golden Rule and I give the Office of Student Conduct permission to release information about violations to the LEAD Scholars Academy.

Benefits & Fellowship

- The total dollar amount of my fellowship is as follows: \$400 LEAD Fellowship each year you are a member of the LEAD Scholars Academy (\$200 during the fall semester and \$200 during the spring semester).
- **I understand that I will receive this amount at the end of each semester only if I am in good standing with the program and have fulfilled all program obligations as listed above.***
- The fellowship is non-deferrable. I must enroll at UCF during the fall 2021 semester.
- It is **required** that you submit the Free Application for Federal Student Aid Form (FAFSA). Should I receive need-based aid, this scholarship plus other aid cannot exceed my total need as defined by the free federal form. Also, my total aid package, including all scholarships cannot exceed the cost of attendance. The University of Central Florida reserves the right to adjust this scholarship to comply with the above University policy.
- I will be granted priority registration starting the spring semester after starting LEAD Scholars so that I may enroll in LDR courses in a timely manner.
